Te Whatu Ora

The Health System in Aotearoa is entering a period of transformation as we implement the Pae Ora/Healthy Futures vision of a reformed system where people live longer in good health, have improved quality of life, and there is equity between all groups.

We want to build a healthcare system that works collectively and cohesively around a shared set of values and a culture that enables everyone to bring their best to work and feel proud when they go home to their whānau, friends and community. The reforms are expected to achieve five system shifts. These are:

1. The health system will reinforce Te Tiriti principles and obligations
2. All people will be able to access a comprehensive range of support in their local communities to help them stay well
3. Everyone will have equal access to high quality emergency and specialist care when they need it
4. Digital services will provide more people the care they need in their homes and communities
5. Health and care workers will be valued and well-trained for the future health system

Context

Capital, Coast & Hutt Valley district provides hospital and health services in primary, secondary and tertiary healthcare to a total population base of approximately 445,000 citizens.

We are accountable for meeting the needs of and improving health outcomes for all the constituent populations of our district, and the region more broadly. Together we:

- provide secondary and tertiary, medical, surgery and mental health and intellectual disability hospital services alongside community based health care
- fund local health providers and work collaboratively with the community to create and support multiple health education initiatives and projects within the region

- deliver health services directly as well as contracting external providers
- provide local, sub-regional, regional and national health services as well as community-based health, rehabilitation and support services.

The majority of the district's population live in Wellington and Lower Hutt. The Māori and Pacific populations of Lower Hutt and Wellington are proportionally similar, with the largest Pacific population in the region in Porirua. Kapiti and Upper Hutt have similar numbers of Māori and Pacific people. Most people are enrolled with a GP near their place of residence, so the increasing focus on community-based healthcare is expected to lead to better health outcomes for these population groups. Hutt Hospital provides secondary and some tertiary, medical and surgical hospital services alongside community based health care from its main facility in Lower Hutt City. In addition to funding local health providers and working collaboratively with the community to create and support multiple health education initiatives and projects, Hutt Hospital is the centre for five tertiary regional and sub-regional services - Plastics, Maxillofacial and Burns Services; Rheumatology; Dental Services; Regional Public Health; and Regional (Breast and Cervical) Screening Services.

Wellington Regional Hospital in Newtown is the region's main tertiary hospital with services such as complex specialist and acute procedures, intensive care, cardiac surgery, cancer care, neurosurgery and renal care. The hospital is the key tertiary referral centre for the lower half of the North Island and the upper half of the South Island.

Kenepuru Community Hospital and Kapiti Health Centre provide secondary and community services based in Porirua and the Kapiti Coast

MHAIDS is the mental health, addiction and intellectual disability service for the Wairarapa District and Capital, Coast & Hutt Valley District, with multiple specialist facilities. The service holds national contracts some of which are delivered in other district localities. Ratonga Rua-o- Porirua is our forensic, rehabilitation and intellectual disability inpatient and community site.

Te Tiriti o Waitangi and Māori Health Outcomes

Māori are the indigenous peoples of Aotearoa. We have particular responsibilities and accountabilities through this founding document of Aotearoa. District Responsibility

The district leadership have collective accountability for leading with integrity and transparency a progressive, high performing organisation, aimed at improving the health and independence of the community we serve and achieving equitable outcomes for all. The leadership team are responsible for achieving this aim, aligned with our Region, within the available resources, through a skilled, empowered, motivated and supported workforce in line with government and HNZ policy.

Service Perspective

The hospital and health services of the Districts provide a range of services, one such group of services includes Mental Health, Addiction and Intellectual Disability (MHAID) Service. The Service has over 1400 employees and annual revenue of \$135m.

MHAIDS spans two districts - Wairarapa, Capital, Coast and Hutt Valley and includes local, regional, and national services. The local MHAID services are provided from multiple sites within the sub-region – greater Wellington, Hutt Valley and Wairarapa. Te Korowai Whāriki services include regional forensic and rehabilitation services covering the Central region while the intellectual disability services extend the length and breadth of the country from six bases located in Whangarei, Auckland, Cambridge, Wellington, Christchurch, and Dunedin.

The core business of the Service is the provision of quality specialist services, integrated with primary and secondary providers in the communities we serve.

The Service has access to business support services including People and Culture, and Finance. In addition, management and delivery of clinical services across the Service is underpinned by consultation, advice, and support from a range of cultural, consumer, and family advisors, and business, quality and organisational development personnel.

Team Perspective

The Regional Intellectual Disability Consultation and Assessment Service (RIDCAS) is a small specialist clinical comprised of clinicians from medical, nursing & psychology.

team provides short term, intensive assessments, recommendations and advice for adult community and inpatient mental health services. We also provide training and education on intellectual disability and mental health related issues to mental health services and NGOs.

We have two contracts:

Our mental health contract provides tertiary services for adults with an intellectual disability and co-existing mental illness. Secondary mental health services are able to directly refer clients with an intellectual disability to us for a mental health assessment.

Our forensic disability contract provides services for clients referred through FCS (ID) Forensic Coordination Service (Intellectual Disability). Our clients are usually Care Recipients under the Intellectual Disability (Compulsory Care and Rehabilitation) Act, 2003 who have been convicted or found unfit to stand trial. They are required to live in a community facility a Regional Intellectual Disability Secure Accommodation Service (RIDSAS) for a period of rehabilitation.

Our services are available to people living in the central region of the North Island and includes Horowhenua, Manawatu, Whanganui, Kapiti, Porirua, Wellington, Hutt Valley, Wairarapa, Hawke's Bay and Tairāwhiti regions (although the forensic contract excludes Tairāwhiti).

RIDCAS is a small team of staffed by team of clinicians from medical, nursing & allied health.

Purpose of the role

To provide a high quality clinical psychology service in the assessment and treatment of clients with an intellectual disability and mental health needs & complex offending and behavioural needs. Key tasks undertaken by the clinical psychologist include:

- Assessment, formulation and treatment of clients on an individual and group basis.
- Consultation to other team members about the day-to-day management of clients.
- The provision of expert advice and assistance to multidisciplinary team members on complex casework matters.
- Cognitive, psychometric and neuropsychological assessment.
- The provision of supervised training to clinical psychology students.
- The provision of clinical supervision to other clinicians.
- Liaison with government and non-government organisations.
- Research and maintenance of knowledge of current and emerging trends and practices concerning clinical psychology, mental health and intellectual disability.
- Contributing to strategic, clinical and operational planning and key decision making processes for the service.

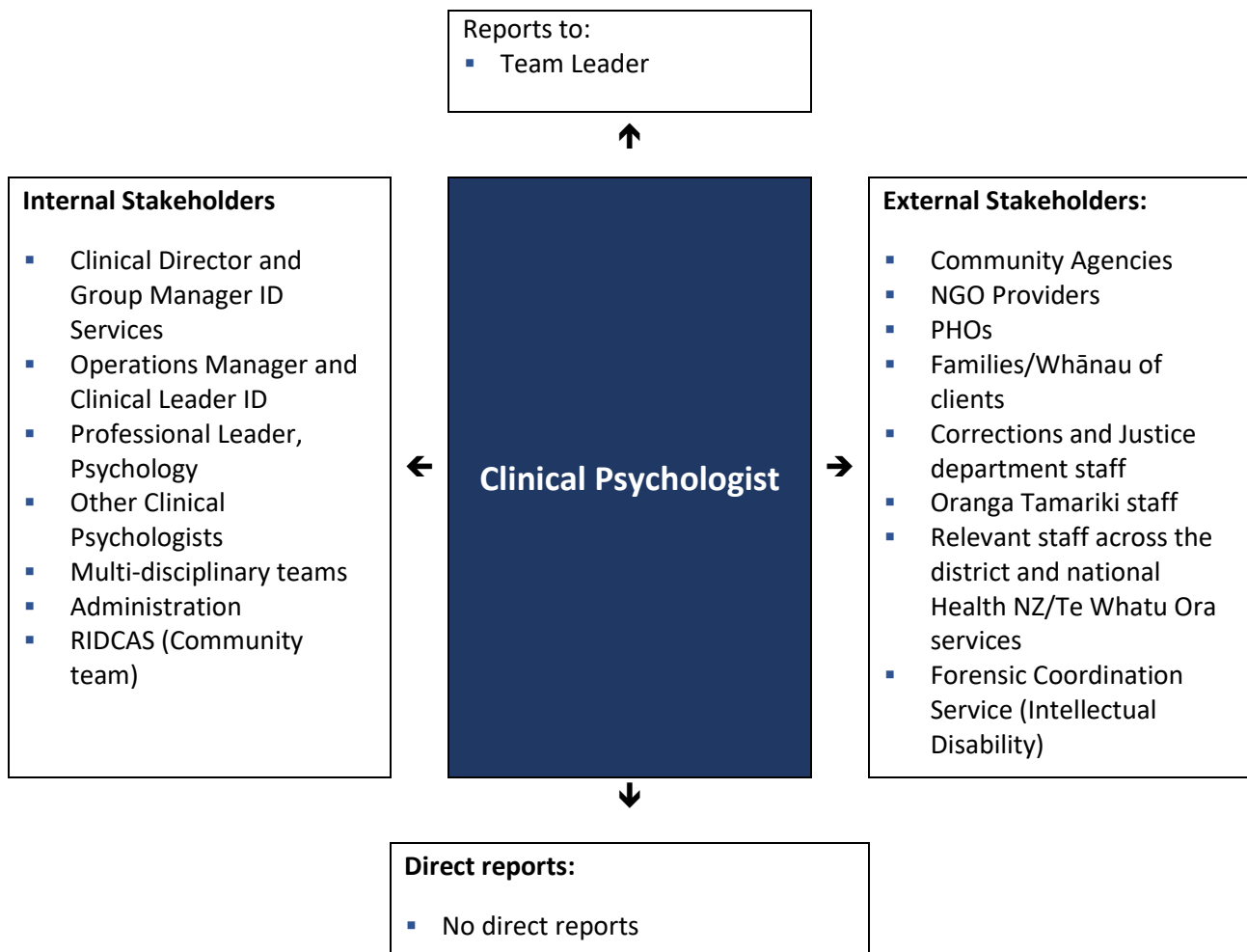

Experience and Capability

Essential qualifications, skills and experience

A. Knowledge, Skills & Experience:

- A sound knowledge of DSM diagnoses and at least one therapy model is essential.
- A sound knowledge of psychometrics and experience with psychological testing.
- Ability to develop sound psychological formulations based on thorough assessments.
- Ability to assess, diagnose and treat people experiencing intellectual disability and emotional and behavioural difficulties.
- Ability to advise, consult and educate the client and relevant others about their psychological formulation and corresponding treatment options.
- Ability to work alongside other mental health staff to provide psychological expertise within the CCDHB integrated care approach.
- Ability to attend and actively participate in regular meetings for the purposes of assessment, planning and implementing treatment.
- Experience in facilitating groups would be advantageous.
- Ability to practice in a manner consistent with established ethical and clinical practices standards as provided by the HPCAA, the Psychologists Board and other professional bodies.

B. Essential Professional Qualifications / Accreditations / Registrations:

- Minimum of a Masters Degree in Psychology and Post graduate Diploma in Clinical Psychology or equivalent.
- Registration with NZ Psychologist Board, with Clinical Psychology as Vocational Scope of Practice.
- Current annual practising certificate.
