About the role

The primary purpose of the role is to:

To provide high quality, liaison, support, and information to clinicians working with tāngata whaiora with significant distress intolerance, emotional dysregulation and relational difficulties that impacts on their day to day life. This includes and is not limited to assisting with the development of Whole Service Response Plans (WSRP), formulation, treatment planning and providing education and support that enable the Mental Health Service to provide psychologically informed care management.

To provide interventions including DBT therapy, evidence based therapeutic interventions, second opinion assessments and group work. Our aim is to also support significant others and whānau ensuring the service user and their whanau's needs are met in a culturally, clinically and legally safe manner.
